ABOUT ROLLY VS. TEOFIMO

Rolly vs. Teofimo will see WBA Welterweight World Champion **Rolly Romero** making the first defense of his world title against two-division world champion **Teofimo Lopez** in a matchup of two of this generations' most compelling champions on Saturday, August 22 headlining a PBC Pay-Per-View event available on DAZN and Prime Video from T-Mobile Arena in Las Vegas.
