## **ABOUT CANELO VS. CHARLO**

Canelo vs. Charlo will see pound-for-pound great Canelo Álvarez defend his undisputed super middleweight world titles in a blockbuster showdown against hard-hitting undisputed junior middleweight world champion Jermell Charlo headlining a SHOWTIME PPV Saturday, September 30 from T-Mobile Arena in Las Vegas.
