CREDENTIAL DISTRIBUTION:

Temporary credentials will be distributed at the “Old MGM Grand Garden Arena Box Office” located outside the MGM Grand Garden Arena porte-cochere (southeast corner of the building at street level) starting Monday, September 11 at 12:00 p.m. and Tuesday, September 12 through Friday, September 15 from 9:00 a.m. through 5:00 p.m. You may claim your fight night credential beginning at 12:00 p.m. on Saturday, September 16 from T-Mobile Arena Box Offices #9-11. Photo ID processing is in place for this event. You will be told when you claim your temporary fight week credential if your photo is already on file – if not, they will take it for you at the same location. You are urged to have your photo taken prior to the Weigh-In on Friday afternoon. If you have not had your photo taken prior to Friday, it will take longer to prepare your credential on Saturday.
