

LAS VEGAS – March 25, 2026 – WBC Super Welterweight World Champion Sebastian “The Towering Inferno” Fundora and former unified champion Keith “One Time” Thurman opened fight week events with an intense stare down and previewed their world championship clash during the live streamed **PBC Opening Bell** show before they step into the ring this Saturday, March 28 headlining a PBC Pay-Per-View event available on Prime Video from the MGM Grand Garden Arena in Las Vegas.

PBC Opening Bell: Fundora vs. Thurman was co-hosted by hip-hop legend and *Talk With Flee* host **Cam'ron**, *It Is What It Is* co-host **Treasure “Stat Baby” Wilson** and veteran boxing journalist **Sean Zittel**, and also featured analysis from WBA Welterweight World Champion **Rolly Romero** and former two-time world champion **Shawn Porter**. In addition, Fundora and Thurman each sat down with the panel and discussed what fans will see in the ring when they finally square off this Saturday night.

“Saturday is not just another night, it’s a historic night,” said Thurman. “Is it my redemption? Or is it the beginning of Fundora’s legacy? That’s what people wanna see.

“We’ve seen what happens to Sebastian’s legs when he got rocked. Can ‘One Time’ do it to Sebastian one more time? I have confidence and I believe in myself. It’s gonna be about the traps I set. How does he avoid all that?”

“I’m a lot for everybody in this division and everybody in this sport,” said Fundora. “Stepping in the ring with me is a problem for anybody.

“I’m evolving and I’m maturing. We’re getting stronger and wiser and bringing that inside the ring. I plan on winning this Saturday and adding another great name to my resume.”

Fundora vs. Thurman will see WBC Super Welterweight World Champion **Sebastian “The Towering Inferno” Fundora** battle former unified champion **Keith “One Time” Thurman** in the main event of a PBC Pay-Per-View event available on Prime Video on Saturday, March 28 from the MGM Grand Garden Arena in Las Vegas.

The action begins at 8 p.m. ET/5 p.m. PT and will feature exciting super welterweights going toe-to-toe in the 12-round co-main event as rising young star **Yoenis Tellez** duels top contender **Brian Mendoza**.

The lineup will also feature undefeated top-rated middleweight **Yoenli Hernandez** stepping in against battle-tested U.S. Olympian **Terrell Gausha** in a 10-round bout, plus undefeated heavyweight slugger **Gurgen Hovhannisyan** steps in to face **Cesar Navarro** in a 10-round showdown opening the pay-per-view at 8 p.m. ET/5 p.m. PT.
