## CANELO ALVAREZ AND DANIEL 'MIRACLE MAN' JACOBS EMBARK ON THREE-CITY INTERNATIONAL PRESS TOUR

LOS ANGELES (February 20, 2019): **Canelo Alvarez** (50-1-2, 34 KOs), WBC, WBA, Lineal and *Ring* Magazine Middleweight World Champion, and **Daniel "Miracle Man" Jacobs** (35-2, 29 KOs), IBF Middleweight World Champion, will kick off an international press tour on Wednesday, Feb. 27 ahead of their 12-round unification fight during the celebratory weekend of Cinco de Mayo. The champion-vs.-champion event will take place Saturday, May 4 at T-Mobile Arena in Las Vegas and will be streamed live exclusively on [DAZN](#).

**The tour will begin in New York City on Wednesday, Feb. 27; will continue in Mexico City on Friday, March 1 and conclude in Los Angeles on Monday, March 4.**
