The June 19 Triller Fight Club (www.trillerfightclub.com) card at Miami's loanDepot park, home of the Miami Marlins and live on Pay-Per-View, is headlined by the highly anticipated clash between Undisputed Lightweight World Champion 'The Takeover' Teofimo Lopez, (16-0, 12 KOs) and Mandatory World Title Challenger George Kambosos, Jr. (19-0, 10 KOs). Also presented on the huge card is a WBA Heavyweight World Title Eliminator clash between Michael Hunter (19-1-1, 13 KOs) and Mike Wilson (21-1, 10 KOs), as well as the WBC International Super Featherweight Silver Championship matchup between Andy Vences (23-2-1, 12 KOs) and Ireland's Jono Carroll (19-2-1, 5 KOs). The co-main bout will feature a four-belt undisputed super middleweight championship between WBC/WBO titlist Franchon Crews-Dezurn, (7-1, 2 KOs), and Sweden's Elin Cederroos, (8-0, 4 KOs), who holds the WBA and IBF belts. The winner will become a true women's undisputed champion in the sport. Additional fights will be announced in the coming weeks.
