LOS ANGELES (July 11, 2024) - The undefeated knockout monster **Vergil Ortiz Jr.** (21-0, 21 KOs) of Grand Prairie, Texas and Vinitza, Ukraine's WBC Interim Super Welterweight World Champion **Serhii "El Flaco" Bohachuk** (24-1, 23 KOs) hosted a press conference today at **Golden Boy HQ** to discuss their upcoming fight for Bohachuk's **WBC Interim Super Welterweight World Championship** title.

As part of the *DAZN* undercard that will be revealed soon, Oscar De La Hoya announced that the undefeated **Gabriela Fundora** (13-0, 6 KOs) will defend her IBF Flyweight World Title against Chile's **Daniela Asenjo** (16-3-3, 2 KOs). Her fight is co-promoted with Sampson Boxing.

The world championship event is presented by **Golden Boy Promotions** in association with 360 Promotions and TGB Promotions. It is scheduled for 12-rounds and is set to take place at the Michelob ULTRA Arena at Mandalay Bay Resort and Casino in Las Vegas on Saturday, August 10, 2024. The exclusive fight night will be broadcast worldwide on *DAZN* beginning at 5:00 p.m. PT.

Tickets starting at \$34 plus applicable fees for Bohachuk vs. Ortiz Jr. are on sale now. A limited amount of Golden Boy VIP Experience tickets will also be available for purchase with exclusive merchandise and fight night upgrades included. **SERHII BOHACHUK, WBC INTERIM SUPER WELTERWEIGHT WORLD CHAMPION:**

"I wanted to fight this fight now. I like it, I like the challenge. This fight can be very beneficial for both of us. Let's go! I can't wait to give Ukraine an opportunity to show a lot of pride. It's going to be a war!"

**VERGIL ORTIZ JR., UNDEFEATED SUPER WELTERWEIGHT WORLD CHAMPION:**

"I am so grateful! Me and Golden Boy just resigned another multi-year contract. I want to thank my dad, first of all, and Robert Garcia, I just want to share my gratitude. We've been training since I was five years old. Hard work every day. I didn't have anything growing up. To be able to give my siblings something, you know, to help them - I want them to have all the stuff I wasn't able to have. Come August 10, you know it's going to be a good fight. I don't think guys understand this is going to be a war."

**GABRIELA FUNDORA, IBF FLYWEIGHT WORLD CHAMPION:**
